Funding Opportunity Purpose

The National Institute on Drug Abuse (NIDA) Cutting-Edge Basic Research Award (CEBRA) is designed to foster highly innovative or conceptually creative research related to the etiology, pathophysiology, prevention, or treatment of substance use disorders (SUDs). It supports high-risk and potentially high-impact research that is underrepresented or not included in NIDA's current portfolio. The proposed research should: (1) test an innovative and significant hypothesis for which there are scant precedent or preliminary data and which, if confirmed, would transform current thinking; and/or (2) develop, and/or adapt, revolutionary techniques or methods for addiction research or that show promising future applicability to SUD research.

Part 2. Full Text of Announcement

Section I. Funding Opportunity Description

Background

This Funding Opportunity Announcement (FOA) invites applications for Cutting-Edge Basic Research Awards (CEBRA) to foster highly innovative or conceptually creative research that advances our understanding of the etiology, pathophysiology, prevention, or treatment of substance use disorders (SUDs). The CEBRA program was designed by NIDA to foster novel research approaches and represents the high priority placed by NIDA on identifying such research. NIDA currently supports a great deal of innovative biomedical research relevant to SUDs and related health problems such as pain, HIV, and obesity. The CEBRA, however, is specifically designed to support research that is high-risk and potentially high-impact and that is underrepresented or not included in NIDA's current portfolio. It is not intended for incremental research or research extending ongoing programs. There is enormous potential for advances when knowledge is generated and combined in new and unexpected ways. Therefore, this announcement encourages applications from investigators with experience in SUD-relevant research who wish to explore and develop new methods, techniques or conceptual frameworks to study basic questions in this research area. It also encourages applications from investigators with expertise in fields other than SUDs who wish to establish innovative research programs in this area or to develop new approaches, techniques or technologies that have the potential for high-impact applications in SUD and related research.

The R21 mechanism supports projects which have a strong rationale and conceptual framework, but are in the early, first stages of development where there are little or no preliminary data available. The CEBRA R21 program is not intended for large-scale undertakings or to support or supplement ongoing research. Applications submitted under this mechanism should be exploratory and novel and describe projects distinct from those supported through the traditional R01 mechanism. The research proposed in a CEBRA application should break new ground or extend previous discoveries toward new directions or applications. For the CEBRA program, "basic research" is broadly inclusive. CEBRA applications will be considered for all NIDA Divisions.

Special features of the CEBRA include:

- Focus on high-risk/high impact technical or conceptual innovation
- Review convened by NIDA.
- Expedited funding decision.

Research Objectives

Pharmacological, neurobiological, behavioral, cell biological and genetic research has provided insight into how addictive drugs exert their actions on the brain and other organs. Neurobiological, behavioral and cognitive studies have shown how addictive drugs affect behavior and information processing in the brain, and have helped to elucidate the normal behavioral and neurobiological processes that are "hijacked" by addictive substances. They have also helped us understand motivational aspects of SUDs and other relevant behaviors, emotional regulation, and decision-making processes.

Basic science discoveries have consistently been the basis for many major advances in both clinical and applied SUD research and have contributed to the development and implementation of successful treatment strategies for SUDs and pain. Basic research has also led to the discovery of new targets for medications, non-addictive treatments for pain, the development of new technologies that enhance prevention and treatment programs for SUDs, and new approaches for statistical analysis of epidemiological and clinical trials data. Basic research to establish new animal models and new methods to synthesize small molecules and immunotherapies has supported the development of new medications to treat SUDs. Basic research has also

addressed how addictive substances interact with viral infections such as HIV, HBV, and HCV. In addition, new technologies and approaches, such as nanobiology, bioengineering, epigenomics, computational science, imaging methods and optogenetics have had a significant impact on cutting-edge research. However, there is still a need to increase our understanding of SUDs and related disorders through basic research in all these areas in order to develop effective diagnostic, treatment and prevention interventions to alleviate the pain and devastation of addiction.

The goal of NIDA's CEBRA program is to accelerate the pace of discoveries to advance addiction research by encouraging scientifically sound applications that focus on innovation. The CEBRA encourages researchers to explore new approaches, test imaginative new ideas, and challenge existing paradigms in drug addiction research. We encourage the development of new mathematical and/or statistical models, advances that incorporate innovative cell biology studies, as well as testing new methods and hypotheses in humans and a variety of animal models. The CEBRA program will support high-risk, high impact research that: (1) tests an innovative and significant hypothesis for which there are scant precedent or preliminary data and which, if confirmed, would transform current thinking; or (2) develops, and/or adapts, revolutionary techniques or methods for addiction research or that show promising future applicability to SUD research.

Special Considerations

HIV/AIDS Counseling and Testing Policy for the National Institute on Drug Abuse: In light of recent significant advances in rapid testing for HIV and in effective treatments for HIV, NIDA has revised its 2001 policy on HIV counseling and testing. NIDA-funded researchers are strongly encouraged to provide and/or refer research subjects to HIV risk reduction education and education about the benefits of HIV treatment, counseling and testing, referral to treatment, and other appropriate interventions to prevent acquisition and transmission of HIV. Only the review criteria described below will be considered in the review process. As part of the [NIH mission \(//grants.nih.gov/grants/guide/url_redirect.htm?id=11149\)](https://grants.nih.gov/grants/guide/url_redirect.htm?id=11149), all applications submitted to the NIH in support of biomedical and behavioral research are evaluated for scientific and technical merit through the NIH peer review system.

For this particular announcement, note the following:

A proposed Clinical Trial application may include study design, methods, and intervention that are not by themselves innovative but address conceptually innovative questions or unmet needs. Additionally, the results of the clinical trial may indicate that further clinical development of the intervention is unwarranted or lead to new avenues of scientific investigation.

For the CEBRA R21, reviewers will emphasize significance and innovation within the goals of the program, which are to support high-risk, high-impact research that either: (1) tests a highly novel and significant hypothesis for which there are scant precedent or preliminary data and which, if confirmed, would have a substantial effect on current thinking; and/or (2) develops or adapts innovative techniques or methods for SUD research, or of potential future use in SUD research if the project is successful.

The R21 exploratory/developmental grant supports investigation of novel scientific ideas or new model systems, tools, or technologies that have the potential for significant impact on biomedical or biobehavioral research. An R21 grant application need not have extensive background material or preliminary information. Accordingly, reviewers will focus their evaluation on the conceptual framework, the level of innovation, and the potential to significantly advance our knowledge or understanding. Appropriate justification for the proposed work can be provided through literature citations, data from other sources, or, when available, from investigator-generated data. Preliminary data are not required for R21 applications; however, they may be included if available.

Overall Impact

Reviewers will provide an overall impact score to reflect their assessment of the likelihood for the project to exert a sustained, powerful influence on the research field(s) involved, in consideration of the following review criteria and additional review criteria (as applicable for the project proposed).

Scored Review Criteria

Reviewers will consider each of the review criteria below in the determination of scientific merit, and give a separate score for each. An application does not need to be strong in all categories to be judged likely to have major scientific impact. For example, a project that by its nature is not innovative may be essential to advance a field.

Significance

Does the project address an important problem or a critical barrier to progress in the field? Is there a strong scientific premise for the project? If the aims of the project are achieved, how will scientific knowledge, technical capability, and/or clinical practice be improved? How will successful completion of the aims change the concepts, methods, technologies, treatments, services, or preventative interventions that drive this field? Does the applicant propose a research project that, if fully successful, will substantially alter current thinking in SUD research or substantially alter our ability to perform future SUD research?

In addition, for applications proposing clinical trials

Are the scientific rationale and need for a clinical trial to test the proposed hypothesis or intervention well supported by preliminary data, clinical and/or preclinical studies, or information in the literature or knowledge of biological mechanisms? For trials focusing on clinical or public health endpoints, is this clinical trial necessary for testing the safety, efficacy or effectiveness of an intervention that could lead to a change in clinical practice, community behaviors or health care policy? For trials focusing on mechanistic, behavioral, physiological, biochemical, or other biomedical endpoints, is this trial needed to advance scientific understanding?

Investigator(s)

Are the PD(s)/PI(s), collaborators, and other researchers well suited to the project? If Early Stage Investigators or those in the early stages of independent careers, do they have appropriate experience and training? If established, have they demonstrated an ongoing record of accomplishments that have advanced their field(s)? If the project is collaborative or multi-PD/PI, do the investigators have complementary and integrated expertise; are their leadership approach, governance and organizational structure appropriate for the project? Does the PD/PI or a member of the team have SUD research experience?

In addition, for applications proposing clinical trials

With regard to the proposed leadership for the project, do the PD/PI(s) and key personnel have the expertise, experience, and ability to organize, manage and implement the proposed clinical trial and meet milestones and timelines? Do they have appropriate expertise in study coordination, data management and statistics? For a multicenter trial, is the organizational structure appropriate and does the application identify a core of potential center investigators and staffing for a coordinating center?

Innovation

Does the application challenge and seek to shift current research or clinical practice paradigms by utilizing novel theoretical concepts, approaches or methodologies, instrumentation, or interventions? Are the concepts, approaches or methodologies, instrumentation, or interventions novel to one field of research or novel in a broad sense? Is a refinement, improvement, or new application of theoretical concepts, approaches or methodologies, instrumentation, or interventions proposed? How well does the proposed project: 1. test an innovative and significant hypothesis for which there are scant precedent or preliminary data (e.g. conceptual innovation) and/or (2) develop or adapt revolutionary techniques or methods (e.g. technical innovation) for SUD research?

In addition, for applications proposing clinical trials

Does the design/research plan include innovative elements, as appropriate, that enhance its sensitivity, potential for information or potential to advance scientific knowledge or clinical practice?

Approach

Are the overall strategy, methodology, and analyses well-reasoned and appropriate to accomplish the specific aims of the project? Have the investigators presented strategies to ensure a robust and unbiased approach, as appropriate for the work proposed? Are potential problems, alternative strategies, and benchmarks for success presented? If the project is in the early stages of development, will the strategy establish feasibility and will particularly risky aspects be managed? Have the investigators presented adequate plans to address relevant biological variables, such as sex, for studies in vertebrate animals or human subjects?

If the project involves human subjects and/or NIH-defined clinical research, are the plans to address 1) the protection of human subjects from research risks, and 2) inclusion (or exclusion) of individuals on the basis of sex/gender, race, and ethnicity, as well as the inclusion or exclusion of children, justified in terms of the scientific goals and research strategy proposed?

In addition, for applications proposing clinical trials

Does the application adequately address the following, if applicable

Study Design

Is the study design justified and appropriate to address primary and secondary outcome variable(s)/endpoints that will be clear, informative and relevant to the hypothesis being tested? Is the scientific rationale/premise of the study based on previously well-designed preclinical and/or clinical research? Given the methods used to assign participants and deliver interventions, is the study design adequately powered to answer the research question(s), test the proposed hypothesis/hypotheses, and provide interpretable results? Is the trial appropriately designed to conduct the research efficiently? Are the study populations (size, gender, age, demographic group), proposed intervention arms/dose, and duration of the trial, appropriate and well justified?

Are potential ethical issues adequately addressed? Is the process for obtaining informed consent or assent appropriate? Is the eligible population available? Are the plans for recruitment outreach, enrollment, retention, handling dropouts, missed visits, and losses to follow-up appropriate to ensure robust data collection? Are the planned recruitment timelines feasible and is the plan to monitor accrual adequate?

Has the need for randomization (or not), masking (if appropriate), controls, and inclusion/exclusion criteria been addressed? Are differences addressed, if applicable, in the intervention effect due to sex/gender and race/ethnicity?

Are the plans to standardize, assure quality of, and monitor adherence to, the trial protocol and data collection or distribution guidelines appropriate? Is there a plan to obtain required study agent(s)? Does the application propose to use existing available resources, as applicable?

Data Management and Statistical Analysis

Are planned analyses and statistical approach appropriate for the proposed study design and methods used to assign participants and deliver interventions? Are the procedures for data management and quality control of data adequate at clinical site(s) or at center laboratories, as applicable? Have the methods for standardization of procedures for data management to assess the effect of the intervention and quality control been addressed? Is there a plan to complete data analysis within the proposed period of the award?

Environment

Will the scientific environment in which the work will be done contribute to the probability of success? Are the institutional support, equipment and other physical resources available to the investigators adequate for the project proposed? Will the project benefit from unique features of the scientific environment, subject populations, or collaborative arrangements?

In addition, for applications proposing clinical trials

If proposed, are the administrative, data coordinating, enrollment and laboratory/testing centers, appropriate for the trial proposed?

Does the application adequately address the capability and ability to conduct the trial at the proposed site(s) or centers? Are the plans to add or drop enrollment centers, as needed, appropriate?

If international site(s) is/are proposed, does the application adequately address the complexity of executing the clinical trial?

If multi-sites/centers, is there evidence of the ability of the individual site or center to: (1) enroll the proposed numbers; (2) adhere to the protocol; (3) collect and transmit data in an accurate and timely fashion; and, (4) operate within the proposed organizational structure?

Additional Review Criteria

As applicable for the project proposed, reviewers will evaluate the following additional items while determining scientific and technical merit, and in providing an overall impact score, but will not give separate scores for these items.

Study Timeline

In addition, for applications proposing clinical trials

Is the study timeline described in detail, taking into account start-up activities, the anticipated rate of enrollment, and planned follow-up assessment? Is the projected timeline feasible and well justified? Does the project incorporate efficiencies and utilize existing resources (e.g., CTSAs, practice-based research networks, electronic medical records, administrative database, or patient registries) to increase the efficiency of participant enrollment and data collection, as appropriate?

Are potential challenges and corresponding solutions discussed (e.g., strategies that can be implemented in the event of enrollment shortfalls)?

Protections for Human Subjects

For research that involves human subjects but does not involve one of the six categories of research that are exempt under 45 CFR Part 46, the committee will evaluate the justification for involvement of human subjects and the proposed protections from research risk relating to their participation according to the following five review criteria: 1) risk to subjects, 2) adequacy of protection against risks, 3) potential benefits to the subjects and others, 4) importance of the knowledge to be gained, and 5) data and safety monitoring for clinical trials.
