Part 2. Full Text of Announcement

Section I. Funding Opportunity Description

A major goal of the National Plan to address Alzheimer's disease and Alzheimer's disease-related dementias (AD/ADRD) is to accelerate the development of treatments that would prevent, delay, or reverse the course of the disease and improve early diagnosis; yet, there is a shortage of scientists to conduct the wide variety of necessary innovative and interdisciplinary research projects, including clinical, translational, prevention, and treatment research on AD/ADRD. This small grant program will address the National Alzheimer's Project Act (NAPA) Milestone 4.I: "to establish new training programs as well as fellowship and career development programs to develop a new translational and data science workforce," especially targeting recruitment of junior investigators to the NIH AD/ADRD portfolio. A major barrier to non-AD researchers obtaining an R01 grant to conduct AD/ADRD research is the lack of critical preliminary data. This FOA is intended to help them overcome this barrier.

Objectives

- Advance early stage investigators (ESIs) committed to pursuing careers in the field of AD/ADRD and aging research, including all qualified researchers from a variety of training and professional backgrounds.
- Invite investigators with training in non-neurological-based medical or surgical fields to shift their research to topic(s) focused on the prevention, diagnosis, treatment, or management of AD/ADRD patients within their field
- Encourage an infusion of investigators from other health research areas to pursue important and novel approaches to research in AD/ADRD.
- Generate high-quality research projects from junior faculty in basic, translational, and clinical research related to AD/ADRD and healthy brain aging.
- Advance ESIs' opportunities to launch a research career focusing on AD/ADRD by helping them accrue pilot data to subsequently submit competitive applications for larger, independent funding awards.
- Build a pipeline of ESIs committed to AD/ADRD research.
- Enhance opportunities for networking, collaboration, and retention in the field.
- Enhance workforce diversity by encouraging individuals from nationally underrepresented groups to apply.

The overall goal of this FOA is to support important and innovative research in areas in which more scientific investigation is needed to improve the prevention, diagnosis, treatment, and care for AD/ADRD. The aim is to encourage the next generation of researchers to pursue research and academic careers in neuroscience, AD/ADRD, and healthy brain aging. Another aim is to stimulate novel research ideas from researchers in other fields. This FOA is primarily focused on archiving and leveraging existing datasets for analyses. Companion FOAs (PAS-19-392 (https://grants.nih.gov/grants/guide/pa-files/PAS-19-393 (https://grants.nih.gov/grants/guide/pa-files/PAS-19-393.html)) focus on 1) computational/biological systems approaches and 2) basic science approaches to elucidate neurodegenerative mechanisms/pathways. NIA expects that at least half of the awards will be made to ESIs in order to meet the goal of fostering their development.

This FOA will support archiving and leveraging existing data sets for analyses of projects on AD/ADRD covering a wide array of topics including, but not limited to, the following:

Understanding AD/ADRD Trajectory for Persons with Dementia (PWD) and their Caregivers

- Prevention, diagnosis, communication, and/or management of specific acute or chronic comorbid conditions in person with AD/ADRD within a medical or surgical specialty
- Evaluation of existing clinical guidelines, standards of care, and/or preventive medicine recommendations for persons with AD/ADRD (e.g., how might we re-cast specific clinical or preventive recommendations for cancer or cholesterol screening within the context of care for persons with AD/ADRD)
- Estimation of the economic burden of AD/ADRD on PWD and their formal or informal caregivers, especially with respect to disparities
- Medical management, including deprescribing approaches, for persons with AD/ADRD experiencing pain,

- delirium, or other multiple comorbid conditions in a variety of settings including emergency, trauma, or critical care; palliative or end-of-life care; or surgical/high risk procedure settings
- Evaluation of strategies for reducing barriers to care, such as transportation, care transitions, remote living situations, living alone, disruptions of daily routine, etc.
- Detection of age-related change in non-cognitive processes (e.g., affective and social functioning) that may represent early signs of AD/ADRD

Health Disparities

- Robust estimation of the prevalence of AD/ADRD in diverse populations
- Improved estimation of the effect of educational attainment on dementia risk, diagnosis, and cognitive assessment across and between populations
- Analyses of pathways that create or sustain AD/ADRD disparities
- Research addressing the unique challenges related to the provision of advanced AD/ADRD care in disparity populations, including disparities in access to care

Cognitive and AD/ADRD Epidemiology

- Improvements in the estimation of the effects of genetic, educational, and environmental risk and protective factors on the rate of cognitive change or conversion to an AD/ADRD diagnosis
- Research focusing on cross-national comparisons, especially those that would inform the identification of new risk or protective factors
- Analyses of big data to improve our ability to detect changes in cognitive function or change points between normal and pathological cognitive aging
- Assessment of differences between cross-national dementia assessments in longitudinal studies
- Exploration of trends in AD/ADRD risk and their explanation via putative risk and protective factors

Data and Archiving

- Augment existing longitudinal cohort studies with linkage to other sources of contextual data
- Electronic archiving and harmonization of complex data sets relevant to AD/ADRD

For this particular announcement, note the following:

The R03 small grant supports discrete, well-defined projects that realistically can be completed in two years and that require limited levels of funding. Because the research project usually is limited, an R03 grant application may not contain extensive detail or discussion. Accordingly, reviewers should evaluate the conceptual framework and general approach to the problem. Appropriate justification for the proposed work can be provided through literature citations, data from other sources, or from investigator-generated data. Preliminary data are not required, particularly in applications proposing pilot or feasibility studies.

The program seeks (i) to facilitate the next generation of researchers in the United States to pursue research and academic careers in neuroscience, AD/ADRD, and healthy brain aging and (ii) to stimulate established researchers who are not currently doing AD/ADRD research to perform initial studies toward developing new, innovative AD/ADRD research programs that leverage and build upon their existing expertise.

Overall Impact

Reviewers will provide an overall impact score to reflect their assessment of the likelihood for the project to exert a sustained, powerful influence on the research field(s) involved, in consideration of the following review criteria and additional review criteria (as applicable for the project proposed).

Scored Review Criteria

Reviewers will consider each of the review criteria below in the determination of scientific merit, and give a separate score for each. An application does not need to be strong in all categories to be judged likely to have major scientific impact. For example, a project that by its nature is not innovative may be essential to advance a field.

Significance

Does the project address an important problem or a critical barrier to progress in the field? Is the prior research that serves as the key support for the proposed project rigorous? If the aims of the project are achieved, how will scientific knowledge, technical capability, and/or clinical practice be improved? How will successful completion of the aims change the concepts, methods, technologies, treatments, services, or preventative interventions that drive this field?

Investigator(s)

Are the PD(s)/PI(s), collaborators, and other researchers well suited to the project? If Early Stage Investigators or those in the early stages of independent careers, do they have appropriate experience and training? If established, have they demonstrated an ongoing record of accomplishments that have advanced their field(s)? If the project is collaborative or multi-PD/PI, do the investigators have complementary and integrated expertise; are their leadership approach, governance and organizational structure appropriate for the project?

Innovation

Does the application challenge and seek to shift current research or clinical practice paradigms by utilizing novel theoretical concepts, approaches or methodologies, instrumentation, or interventions? Are the concepts, approaches or methodologies, instrumentation, or interventions novel to one field of research or novel in a broad sense? Is a refinement, improvement, or new application of theoretical concepts, approaches or methodologies, instrumentation, or interventions proposed?

Approach

Are the overall strategy, methodology, and analyses well-reasoned and appropriate to accomplish the specific aims of the project? Have the investigators included plans to address weaknesses in the rigor of prior research that serves as the key support for the proposed project? Have the investigators presented strategies to ensure a robust and unbiased approach, as appropriate for the work proposed? Are potential problems, alternative strategies, and benchmarks for success presented? If the project is in the early stages of development, will the strategy establish feasibility and will particularly risky aspects be managed? Have the investigators presented adequate plans to address relevant biological variables, such as sex, for studies in vertebrate animals or human subjects?

If the project involves human subjects and/or NIH-defined clinical research, are the plans to address 1) the protection of human subjects from research risks, and 2) inclusion (or exclusion) of individuals on the basis of sex/gender, race, and ethnicity, as well as the inclusion or exclusion of individuals of all ages (including children and older adults), justified in terms of the scientific goals and research strategy proposed?

Environment

Will the scientific environment in which the work will be done contribute to the probability of success? Are the institutional support, equipment and other physical resources available to the investigators adequate for the project proposed? Will the project benefit from unique features of the scientific environment, subject populations, or collaborative arrangements?

Additional Review Criteria

As applicable for the project proposed, reviewers will evaluate the following additional items while determining scientific and technical merit, and in providing an overall impact score, but will not give separate scores for these items.

Protections for Human Subjects

For research that involves human subjects but does not involve one of the categories of research that are exempt under 45 CFR Part 46, the committee will evaluate the justification for involvement of human subjects and the proposed protections from research risk relating to their participation according to the following five review criteria: 1) risk to subjects, 2) adequacy of protection against risks, 3) potential benefits to the subjects and others, 4) importance of the knowledge to be gained, and 5) data and safety monitoring for clinical trials.

For research that involves human subjects and meets the criteria for one or more of the categories of research that are exempt under 45 CFR Part 46, the committee will evaluate: 1) the justification for the exemption, 2) human subjects involvement and characteristics, and 3) sources of materials. Inclusion of Women, Minorities, and Individuals Across the Lifespan

When the proposed project involves human subjects and/or NIH-defined clinical research, the committee will evaluate the proposed plans for the inclusion (or exclusion) of individuals on the basis of sex/gender, race, and ethnicity, as well as the inclusion (or exclusion) of individuals of all ages (including children and older adults) to determine if it is justified in terms of the scientific goals and research strategy proposed. AVMA Guidelines for the Euthanasia of Animals. Reviewers will assess the use of chimpanzees as they would any other application proposing the use of vertebrate animals. Biohazards

Reviewers will assess the information provided in this section of the application, including 1) the Select Agent(s) to be used in the proposed research, 2) the registration status of all entities where Select Agent(s) will be used, 3) the procedures that will be used to monitor possession use and transfer of Select Agent(s), and 4) plans for appropriate biosafety, biocontainment, and security of the Select Agent(s).

Resource Sharing Plans

2. Review and Selection Process

Applications will be evaluated for scientific and technical merit by (an) appropriate Scientific Review Group(s)

convened by the Center for Scientific Review, in accordance with NIH peer review policy and procedures (//grants.nih.gov/grants/guide/url_redirect.htm?id=11154), using the stated review criteria. Assignment to a Scientific Review Group will be shown in the eRA Commons.

As part of the scientific peer review, all applications:

- May undergo a selection process in which only those applications deemed to have the highest scientific and technical merit (generally the top half of applications under review) will be discussed and assigned an overall impact score.
- Will receive a written critique.

Applications will be assigned on the basis of established PHS referral guidelines to the appropriate NIH Institute or Center. Applications will compete for available funds with all other recommended applications. Following initial peer review, recommended applications will receive a second level of review by the appropriate national Advisory Council or Board. 
